**CENTRAL UNION ELEMENTARY SCHOOL DISTRICT  
INTERDISTRICT TRANSFER STUDENT CONTRACT**

Pursuant to the provisions of Board Policy 5117, my child(ren), \_\_\_\_\_ has been granted the privilege to attend school in the Central Union School District, by virtue of an agreement between \_\_\_\_\_ and Central Union Elementary School District. I understand and agree that my student may continue attending Central Union Elementary Schools only under the following conditions:

1. The student does not engage in any student misconduct, including, but not limited to, the violation of law, school rule or school directives, whether or not such misconduct constitutes a violation of Education Code section 48900, et seq.;
2.
  - a. The student maintains a satisfactory record of attendance, including timely attendance which means that a student must be present 90% of the school year or 162 days out of 180. Attendance under 90% will be an automatic revocation of this interdistrict contract.
  - b. Truancy per the California Education Code §48260 states that any child subject to compulsory full time education or to compulsory continuation education who is absent from school without valid excuse three (3) full days in one school year or tardy or absent for more than any 30-minute period during the schoolday without a valid excuse on three (3) occasions in one school year, or any combination thereof, is a truant and shall be reported to the Central Union School District Superintendent. *Truancy is an automatic revocation of this interdistrict contract.*
  - c. Tardy is defined as the student not being in his/her assigned seat when the bell rings for the beginning of school. Students who have seven (7) or more tardies will have their interdistrict contract revoked.
3. The student maintains grades of "C" or "S" or better in all classes. "D", "F", "U", "Needs Improvement" "Incomplete", or "No Mark" are all considered unsatisfactory grades;
4. The attendance of the student is based upon relocation into base housing upon eligibility of housing, if the grade level, for both elementary schools located on the military installation, is not greater than 90% of capacity for grades K-3 and 95% for grades 4-8. The period of acceptance will be any time during the current school year. If the grade level is full to capacity the requester will be put on a

waiting list by date the interdistrict request is posted as received. In addition the interdistrict requester will be required to produce, at the expiration of their original housing letter, an additional letter from housing stating that there has been an extension to the original housing letter. If the requester is unable to provide the extension letter the interdistrict transfer may be revoked.

5. I understand and agree that it is my responsibility to provide transportation for my child to and from school. I understand and agree that my child is to be picked up from school following the dismissal from class no later than fifteen (15) minutes after dismissal unless under the direct supervision of a teacher for a specified reason (*athletics, band, etc.*)
  
6. I understand and agree that the District may place my student at a particular school or in a particular class within the District at its discretion, and that the District may make this placement after consideration of availability of space in a class or at a school. I further understand and agree that the District may change this initial placement as concerns regarding availability of space change. I specifically understand and agree that the District faces certain limits upon class size, and that my student will not be permitted to displace a student residing within the District.

I understand and agree that I provided certain information to the District to aid in its evaluation of my interdistrict transfer agreement and that I did so voluntarily after providing my express consent.

I understand and agree that I must renew my interdistrict transfer agreement annually.

I understand and agree that the failure of me or my student to abide by and follow these conditions on a daily basis may result in the unilateral rescindment of the interdistrict transfer permit and the necessity of my child attending school in the district of residence.
