

NOTICE TO BIDDERS

Notice is hereby given that Central Union School District (hereinafter referred to as “Owner”) will receive sealed bids prior to the date and time stated for the Bid Opening for the award of the Contract to construct:

PROJECT SCOPE:

Project consists of two new kindergarten buildings and associated site work as described in the construction documents. The site work shall include but not be limited to the provisions of concrete walks, fire alarm, modified landscaping, and irrigation. Contractor shall connect all electrical, fire alarm, data connections, irrigation, water and sewer systems as required for complete and operational systems.

Contractor shall be responsible for schedule sequencing of this project to protect and ensure legal occupancy of the existing relocatable classrooms until the two new kindergarten buildings attain substantial completion and occupancy. Upon substantial completion of the new kindergarten buildings, demolition and removal of the two existing relocatable classrooms and associated site work and systems can commence.

The lowest bid shall be determined:

on the amount of the base bid.

This Contract is subject to prequalification. If a bidder is not prequalified to bid on the Contract, Owner will not accept the bid. Bidders must submit the prequalification application to the Owner by the date specified in the application. Bidders may obtain the prequalification application from the Owner. <http://www.central.k12.ca.us/departments/business>

The Project is being funded through the Office of Public-School Construction (OPSC). Bidders must comply with the requirement set forth by the State of California for Public Works construction.

Public works projects shall be subject to compliance monitoring and enforcement by the Department of Industrial Relations. For all projects over Twenty-five Thousand Dollars (\$25,000), a contractor or subcontractor shall not be qualified to submit a bid or to be listed in a bid proposal subject to the requirements of Public Contract Code section 4104 unless currently registered and qualified under Labor Code section 1725.5 to perform public work as defined by Division 2, Part 7, Chapter 1 (§§ 1720 et seq.) of the Labor Code. For all projects over Twenty-five Thousand Dollars (\$25,000), a contractor or subcontractor shall not be qualified to enter into, or engage in the performance of, any contract of public work (as defined by Division 2, Part 7, Chapter 1 (§§ 1720 et seq.) of the Labor Code) unless currently registered and qualified under Labor Code section 1725.5 to perform public work.

Time is of the essence in this Contract, and the time of Completion for the Work (“the Contract Time”) shall be Two Hundred Eighty Seven (287) calendar days from (a) the date of commencement of the Work as established in the Owner’s Notice to Proceed, or (b) if no other date is established in a Notice to Proceed from Owner, the date of Contractor’s actual commencement of the Work (including mobilization).

Bids will be sealed and filed in the Business Office of the Owner at:

on September 3, 2020, before 2:00 p.m. on the clock designated by the Owner or its representative as the bid clock. Facsimile (FAX) copies of the bid will not be accepted.

Bids will be opened on September 3, 2020, at Central Union Elementary School District 15783 18th Avenue, Lemoore CA 93245 at 2:00 p.m. as calculated by the clock designated by the Owner or its representative as the bid clock.

Two Mandatory Pre-bid conferences will be held on August 12, 2020 at 9:00 a.m. and at 11:00 a.m. at Reeves Bypass & Enterprise Ave, Lemoore, CA 93245. Bidders not attending one of the conferences will be disqualified. School District Staff will meet with potential bidders fifteen minutes (15 min.) prior to the schedule time to grant access to the site. Potential bidders shall limit the number of employees attending the Pre-Bid Walk to a maximum of two (2) employees. Access to the site is limited. The District the ability to sponsor two vehicles per CUESD employee, and no more than 10 people (i.e., 5X2 per vehicle).

The drivers still must have insurance and CDL, and the attendees must have valid CDL.

NASL will not be able to process the pass verification as was outlined in the bid docs, the time will not allow that.

All awarded contractors/subcontractors will be vetted prior to accessing the installation. Each individual requiring access must complete a SECNAV 5512 form for the vetting process. A favorable response on the vetting and fitness determination is required to receive access to

DOD-controlled installation/facilities.

COVID-19 guidelines and procedures for all construction sites and workers at all public works must be implemented at all times. Each Bidder and all Subcontractors will be required to abide by the California Department of Industrial Relations (DIR) Division of Occupational Safety & Health Publications Unit SAFETY AND HEALTH GUIDANCE COVID-19 INFECTION PREVENTION IN CONSTRUCTION guidelines, <https://www.dir.ca.gov/dosh/coronavirus/COVID-19-Infection-Prevention-in-Construction.pdf> Contactors and Subcontractors will be required to stay updated on any changes to the DIR guidelines and to make sure they remain within compliance.

The Owner will require the successful Bidder to achieve the minimum goal of 3% DVBE (Disabled Veteran Business Enterprises) established in the bidding documents or to provide acceptable evidence of good faith efforts to do so. The DVBE documents must be sealed and filed in the Business Office of the Owner at the same time the bid is sealed and filed.

Bids must be accompanied by a bidder's bond, cashier's check, or certified check for at least ten percent (10%) of the amount of the base bid and made payable to the Owner. If a bid bond is used, it must be issued by an Admitted Surety (an insurance organization authorized by the Insurance Commissioner to transact surety insurance in the State of California during this calendar year), which shall be given as a guarantee that the bidder will enter into a Contract if awarded the Work and will be declared forfeited, paid to, or retained by the Owner as liquidated damages if the bidder refuses or neglects to enter into the Contract provided by the Owner after being requested to do so. The surety insurer must, unless otherwise agreed to by Owner in writing, at the time of issuance of the bond, have a rating not lower than "A-" as rated by A.M. Best Company, Inc. or other independent rating companies. Owner reserves the right to approve or reject the surety insurer selected by Contractor and to require Contractor to obtain a bond from a surety insurer satisfactory to the Owner.

Bids must be accompanied by an executed Fingerprinting Notice and Acknowledgment.

Pursuant to the Contract Documents, the successful bidder will be required to furnish a Payment (Labor and Material) Bond in the amount of one hundred percent (100%) of the Contract Sum, and a Faithful Performance Bond in the amount of one hundred percent (100%) of the Contract Sum, said bonds to be secured from Admitted Surety insurers (an insurance organization authorized by the Insurance Commissioner to transact business of insurance in the State of California during this calendar year). The surety insurers must, unless otherwise agreed to by Owner in writing, at the time of issuance of the bonds, have a rating not lower than "A-" as rated by A.M. Best Company, Inc. or other independent rating companies. Owner reserves the right to approve or reject the surety insurers selected by the successful bidder and to require the successful bidder to obtain bonds from surety insurers satisfactory to the Owner. The bidder will be required to furnish insurance as set forth in the Contract Documents.

The successful bidder will be allowed to substitute securities or establish an escrow in lieu of retainage, pursuant to Public Contract Code Section 22300, and as described in the Agreement Between Owner and Contractor and General Conditions.

The Owner will not consider or accept any bids from contractors who are not licensed to do business in the State of California, in accordance with the California Public Contract Code, providing for the licensing of contractors. In accordance with Section 3300 of said Code, the bidder shall have a Class "B" license and shall maintain that license in good standing through Completion of the Contract and all applicable warranty periods. Bidder shall state the California contractor license number, and for all projects over Twenty-five Thousand Dollars (\$25,000) the public works contractor registration number, on the Designation of Subcontractors form for all subcontractors doing more than one-half of one percent (0.5%) of the bidder's total bid. An inadvertent error in listing a California contractor's license number shall not be grounds for filing a bid protest or for considering the bid nonresponsive if the bidder submits the corrected contractor's license number to the Owner within 24 hours after the bid opening, or any continuation thereof, so long as the corrected contractor's license number corresponds to the submitted name and location for that subcontractor.

Subcontractors shall maintain their licenses in good standing through Completion of the Contract and all applicable warranty periods. Owner reserves the right to reject any bid as nonresponsive if bidder or any subcontractor is not licensed in good standing from the time the bid is submitted to Owner up to award of the Contract, whether or not the bidder listed the subcontractor inadvertently, or if a listed subcontractor's license is suspended or expires prior to award of the Contract. Owner also reserves the right to reject any bid as non responsive if a listed subcontractor's license is not in good standing to perform the work for which it is listed from the time of submission of the bidder's bid to award of the Contract.

The Director of Industrial Relations of the State of California, in the manner provided by law, has ascertained the general prevailing rate of per diem wages and rate for legal holidays and overtime work. The Contractor must pay for any labor therein described or classified in an amount not less than the rates specified. Copies of the required rates are on file at the Owner's business office and are available to any interested party on request.

The Owner reserves the right to waive any irregularity and to reject any or all bids.

Unless otherwise required by law, no bidder may withdraw its bid for a period of sixty (60) days after the date set for the opening thereof or any authorized postponement thereof. The Owner reserves the right to take more than sixty (60) days to make a decision regarding the rejection of bids or the award of the Contract.
