

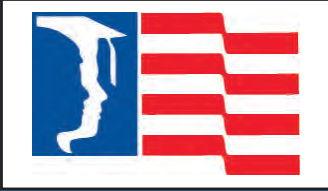

NAFIS Fall Conference Explores Modern Advocacy

IMPACT

In mid-September, the NAFIS Family gathered in Washington, DC, to celebrate a significant milestone. The 2023 NAFIS Fall Conference theme was “Celebrating 50 Years of Impact Aid Advocacy,” and celebrate we did! The conference included a special anniversary dinner that featured a congratulatory video message from U.S. Secretary of Education Miguel Cardona and recognition of four key congressional supporters with the NAFIS Golden Champion Award (*learn more on page 12*).

Over the past 50 years, Impact Aid recipients have developed a sense of community that has been a hallmark of our organization – the NAFIS Family. As we celebrated this anniversary, this community – and the unity it brings to our work – was highlighted during a panel of NAFIS subgroup leaders (*see page 9*).

In addition to reflecting on the past, the conference prepared us to move forward. NAFIS is an advocacy organization committed to strengthening and protecting Impact Aid, one of the largest federal and one of the few education programs that enjoys significant bipartisan support from Congress. That support is due in large part to the efforts of NAFIS and the NAFIS Family over the past 50 years. Our legislative achievements are a key point of pride – and as we look to the future, we want to ensure our advocacy remains effective.

Modern Advocacy

To help us do so, we heard from Brad Fitch, Congressional Management Foundation (CMF) President & CEO, who shared a data-based presentation on advocacy in today’s context.



All advocates compete for congressional attention all the time. Congress gets 50 million constituent emails a year. Members of the House of Representatives and their staff have around 25 meetings a day. How do you and your issue break through?

CMF research shows that Members of Congress and their staff most prefer to get meeting requests from constituents, rather than lobbyists – specifically, constituents who are experts in the issue and who represent other constituents (for example, school board members or superintendents). In one CMF focus group, a staffer noted, “The most effective way to influence a lawmaker is for a constituent to talk to a legislator about how the policy will affect the person or a particular group.”

Research on what influences a Member of Congress when they haven’t decided on an issue has gotten the same results for 20 years. The biggest influencer: in-person **constituent visits**. Contact from constituents’ representatives and individualized email messages also have influence, but form emails have very little.

It is critical you are prepared for congressional meetings. Bring data on how the policy impacts the congressional district or state (90% of staffers told CMF that constituents “frequently” or “very frequently” don’t). Also know your Member’s history or position on the issue (87% of staffers say constituents “frequently” or “very frequently” don’t). Be specific with your request, convey a personal story related to the issue, and do not be rude, whether meeting with the Member or a staffer (remember – the last person the Member will talk with before deciding whether or not to co-sponsor legislation is that staffer). Visuals are more impactful than spreadsheets – bring photos of students, teachers, schools or whatever will best make your case.

Congress Needs a NAFIS Conference

Over the past five decades, NAFIS has weathered challenges, adapted to changing educational landscapes, and strengthened our advocacy for Impact Aid. This resilience and longevity are testaments to the dedication of our passionate members and the critical role the NAFIS Family plays in the lives of students and communities. Fifty years is a significant milestone, and NAFIS celebrated in style at our annual fall conference. We reflected on our storied history, celebrated our accomplishments, and looked forward to the future of modern advocacy. Could you imagine what Congress could do if they listened a bit more and connected with their colleagues like we do? If Members of Congress valued learning and connection more than opposition and re-election, what a different world it would be.

The heart of any successful conference lies in the connections it fosters. The ballroom was filled with the joy of reuniting with old friends and the excitement of making new ones. Every time we gather in DC, I look forward to seeing so many familiar faces and meeting first-time attendees, as well as what I can learn from everyone. NAFIS schools nationwide are on the cutting edge of innovation and share their knowledge with peers both formally during conferences sessions and informally in conversations with colleagues. For example, I got to speak to representatives from Keller School District (WA), where they are purchasing park model homes (think tiny house meets mobile home) to help alleviate the shortage of housing for staff. They park the houses near the school and install everything needed for modern living. NAFIS conferences provide a platform to share information like this with other school leaders and with Congress.

Connecting with colleagues from different geographic regions enriches our perspectives and reminds us of the vast diversity within our organization. Through engaging conversations and collaborations, we discover that

the challenges we face are often remarkably similar, irrespective of where we hail from. Again, Congressmen should put the next NAFIS conference on their calendar, which by the way is March 10-12, 2024. Our biannual gatherings create a sense of unity that is both inspiring and humbling to observe. That unity was reinforced at this event by a panel of subgroup leaders who represent the different federal impactations within NAFIS. Never taking themselves too seriously, these individuals are experts in the communities they serve and have been mentors to me since I began my journey with NAFIS.

Unity. What a funny word to use in Washington, DC, these days. Impact Aid truly is a unifier. In the disarray and disunity that is the House of Representatives right now, Impact Aid is a bit of a unicorn. Few education programs enjoy the bipartisan support we do. We can only benefit from this bipartisanship if Congress is able to function and pass appropriations bills with an increase to Impact Aid, though. A girl can dream, right?

NAFIS was disappointed to see the House Appropriations Subcommittee on Labor-HHS-Education slash many education programs that benefit our members, but we are thankful they level-funded Impact Aid. That's a win in this political climate, but we're

not out of the woods yet because if Congress can't pass spending bills by January, we could see a 1% cut to non-defense discretionary spending for Fiscal Year 2024. During the conference, we heard about this and other legislative developments and how each individual can play an active role in influencing policy decisions. Our collective advocacy efforts gained momentum as we rallied together, uniting to raise awareness and emphasize the vital role Impact Aid plays in our communities. As a result of your advocacy on Hill Day, we have more cosponsors for key legislation, which amplifies the NAFIS message.

The 50th anniversary conference was a resounding success not only in bringing together colleagues from across the country and providing a platform for advocating for Impact Aid, but in fostering a culture of learning from each other and from our excellent speakers. We heard from motivational teacher extraordinaire Michael Bonner, learned how advocacy has changed in recent years from Brad Fitch at the Congressional Management Foundation, and celebrated our congressional champions by awarding the NAFIS Golden Champion Award to Sen. Patty Murray (WA), Sen. John Thune (SD), Rep. Tom Cole (OK), and Rep. Bobby Scott (VA). The connections we forged, the advocacy we engaged in, and the knowledge we shared helped reaffirm our commitment to the Impact Aid community.

As we reflect on this milestone, we are reminded that our organization's journey is far from over. The challenges in public education are evolving, and our role in advocating for Impact Aid is as vital as ever. The conference was not just a celebration of the past; it was a call to action for the future. It serves as a reminder that, as a united community, as the NAFIS Family, we can continue to make a difference in the lives of students and the communities we serve. Here's to the next fifty years of connection, advocacy, and learning! ~

FY 2025 Impact Aid Applications Due January 31, 2024

Fiscal Year (FY) 2024 Initial Payments

The Impact Aid Program (IAP) has begun releasing Section 7003 Basic Support payments to local educational agencies (LEAs) that have requested an early payment. As of October 13, IAP has released 767 payments at 50% LOT and \$500 per weighted student unit for Children with Disabilities (CWD).

Given uncertainty around FY 2024 appropriations, if your LEA will require an initial Impact Aid payment before December 30, 2023, to meet operational expenses, request an expedited payment through the Impact Aid Grant System (IAGS). Find instructions for submitting the request through IAGS on ImpactAid.ed.gov. While all available funds have been distributed at this point, IAP will release additional payments as soon as they receive additional funds.

FY22 Closed Out

FY 2022 has been completely closed out. Final 7003 (b) and (d) payments were made on September 11, 2023, at a 100.938% LOT and \$1,197.05 per Weighted Student Unit (WSU) for Children with Disabilities.

Final 7002 payments were made on October 3, 2023, and final 7007(a) formula construction final payments were made

on October 10, 2023. Check IAGS for your vouchers. You will be able to dispose of your supporting documents for the FY 2022 application in October 2026.

IAGS Multi-Factor Authentication (MFA)

As of August 29, to meet current cybersecurity requirements, IAGS requires school district and state users to access the system through an identity verified Login.gov account. If you need help with your Login.gov account set-up, download this [slide deck](#) with detailed instructions and screenshots or a [Frequently Asked Questions document](#) for more information. Impact Aid staff

are unable to assist with Login.gov identity verification, password or authentication issues. The Login.gov helpdesk is open 24 hours a day, 7 days a week, at <https://login.gov/help> or (844) 875-6466.

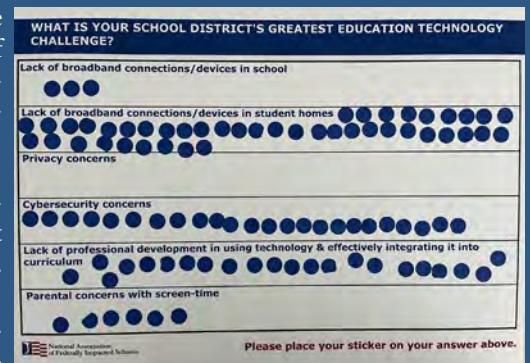

NAFIS Members Rate EdTech Challenges

During the 2023 NAFIS Fall Conference, each attendee was given a sticker to mark the most pressing education technology challenge in their district on a poster. Nearly half said that “lack of broadband connection/devices in student homes” is currently their biggest ed tech challenge. Many also selected “cybersecurity concerns” and “lack of professional development in using technology and effectively integrating it into curriculum”.

A few attendees cited “parental concerns with screen-time” or a “lack of broadband connection/devices in schools,” while no attendees said selected “privacy concerns”. That does not mean those concerns do not exist, but they are not the most pressing right now.

NAFIS members can see from the responses they are not alone in technology struggles. NAFIS will explore these issues in upcoming newsletters and conference programming.

Many Members are excited to hold virtual meetings, which can be very effective and have just as much influence as in-person meetings. Fitch says to think of these meetings like a production – they need a script, a cast (the lead, the storyteller, the subject matter expert) and a director.

Members of Congress get more death threats than thank you notes, so they are very impactful. The best time to send a thank you email is at night or over the weekend, to avoid getting caught in the daily deluge.

In recent years, grassroots work back home in the congressional district has become much more important – it is critical to put a real face on complicated issues. Invite Members of Congress to visit your school or district. Get to know the district director, who will likely have a much longer tenure than a legislative aide. And participate in telephone or online town halls, the use of which grew exponentially during COVID. If you participate, always ask (or try to ask) a question – these town halls can have audiences of thousands, so getting your Member on record supporting your position is a key win.

In-person town halls are even better to attend than virtual – the average attendance is just 25, so you are likely to connect with the Member and perhaps be introduced to a key contact on the issue.

Social media can be an important tool, especially Facebook and Twitter (now X). To ensure a post has influence, be clear that you are a constituent. Also make clear if you lead or represent a group or are affiliated with one (see [NAFIS sample tweets](#) to help you get started).

According to Fitch, the least used tool – but an effective one – is the letter to the editor. If you mention the Member of Congress, they will see it. One note: If you criticize the Member, do it softly and in a way that shows you are reasonable – for example, start it, “I was disappointed when the Congressman...”. Even if your letter is not published, send a copy to the congressional office to show you have a platform and are not afraid to use it.

Finding Your Why

In addition to having the tools to advocate, conference keynote speaker Michael Bonner emphasized it is important to find your “why” for doing so. Bonner, a practicing teacher, gave an engaging, inspiring presentation to motivate attendees to succeed on the Hill and then go home and make the changes needed to improve students’ lives. A key question he asked attendees to ponder: How will they make change happen when they leave Capitol Hill?

A long-time educator, Bonner knows that true change in education is hard. A new curriculum won’t do it, and money alone won’t do it. The people in the school building do it.

He encouraged attendees to get their teachers to buy in to the vision of change. He spoke to the need for innovation in education that mimics the innovation in other sectors and lamented intellectually stubborn individuals who can’t change their minds.

He also spoke of the need to focus on culture and climate and to build self-efficacy in students. He suggested educators put students in situations where they practice skills like collaboration and self-regulation. He asked the audience to survey students to find out how they want to be educated and emphasized the need for adults to model the behavior they want students to engage in. Bonner also discussed relational equity in dealing with students, noting that “You can’t demand a withdrawal from someone you have never invested in”.

Bonner closed by challenging the audience to “find your why.” Sharing that he initially hated that phrase, he now clearly understands it. Your “why” is your anchor, keeping you sturdy when a storm comes. It keeps you grounded when you are too tired, when the policymakers say no to your ask, when it is just too hard. You need your why to make change happen.

For him, “the students are literally everything...they are the reason we do what we do.” We can make change in education, but it doesn’t start at the macro level. It starts at the micro level, with those in the room making small adjustments.

Legislative Update

No New Speaker of the House Yet

The House of Representatives still does not have a Speaker. More than two and a half weeks after it removed Kevin McCarthy (R-CA) from that post and following the failed candidacies of House Majority Leader Steve Scalise (R-LA) and Judiciary Committee Chair Jim Jordan (R-OH), Rep. Patrick McHenry (R-NC) remains Speaker Pro Tem, with very limited powers. As a result, the House is unable to pass any legislation, including FY24 spending bills and Ukraine and Israel funding. The odds of a federal government shutdown after November 17, when the current temporary spending measure expires, continue to increase.

FY 2024 Appropriations

Right now, there is no real path forward on finalizing FY24 appropriations. There are also limited prospects for extending the existing Continuing Resolution (CR) beyond November 17, making a federal government shutdown very possible. Still, the House and Senate managed against all odds to pass the initial 45-day CR and prevented a shutdown on October 1, so hope remains alive.

There are many major hurdles to Congress finishing its work on the 12 appropriations bills. The most significant is funding levels, with the House approving partisan bills with steep funding cuts – particularly in education – and the Senate approving bipartisan bills with mainly level funding. There are signs the House could reverse its position on funding cuts, though. In a recent interview, veteran House Appropriator Tom Cole (R-OK) indicated with Speaker McCarthy's ouster, his decision to support deep spending cuts may no longer hold. If that is the case, the House might end up passing the bipartisan Senate funding bills, resolving the funding crisis. However, it is still unclear who will become Speaker and whether they would risk the wrath of the very House conservatives who engineered McCarthy's removal by blocking funding cuts.

Impact Aid remains in good position to receive at least the same amount it received last year, or a modest increase. It was level-funded in the House Appropriations Subcommittee's FY24 Labor-HHS-Education spending bill, which cut nearly all other K-12 programs, and got an approximately \$10 million increase in the Senate Appropriations Committee's version of that bill. However, if Congress fails to pass all spending bills by January 1, 2024, Impact Aid would be sub-

ject to the 1% across the board cut that all federal programs would sustain.

There are many options for how the next six weeks could transpire:

- Congress passes all 12 FY24 Appropriations bills before November 17 – **unlikely**.
- Government shuts down on November 17 with no agreement on FY24 appropriations or no new short-term CR – **highly possible**.
- Congress passes a short-term CR, then:
 - A. Passes a full-year CR setting FY24 government spending at FY23 levels – **possible**.
 - B. Congress passes all 12 FY24 Appropriations bills before the end of 2023 – **unlikely but possible** if Rep. Cole is correct.
 - C. Congress fails to pass FY24 Appropriations or a full-year CR and all spending programs receive a 1% cut (this is a provision of the Fiscal Responsibility Act passed earlier in 2023) – **possible**. *The caveat here is that it is also possible that Congress could waive this provision and extend the FY24 appropriations process into 2024.*

Impact Aid Infrastructure Partnership Act

The Impact Aid Infrastructure Partnership Act, which would add \$1 billion over four years to the Impact Aid Construction line, was introduced in the Senate in September. Led by Senator Mazie Hirono (D-HI), with 10 co-sponsors, 25% of new funds would be available via formula, with eligibility expanded beyond what is currently in law. The remaining 75% would be distributed as competitive grants. The bill would also allow funds to be used to renovate and construct teacher housing, which is not currently permitted.

This legislation is a longstanding priority for NAFIS, and we are working with Congress to introduce a companion bill in the House.

Impact Aid Full Funding Bill

In March, the Advancing Toward Impact Aid Full Funding Act was introduced in both the House and the Senate. This bipartisan bill would establish a five-year glidepath to significantly increase Impact Aid funding. It would fully fund the Basic Support formula and provide a proportional increase to the Federal Property program, as well as increase funding for the Children with Disabilities and Construction programs.

Thank you, NAFIS Family for your strong advocacy on this legislation! There are now 31 Representatives and 10 Senators signed on, showing growing understanding of the need to fully fund Impact Aid.

Homework Gap/E-Rate

The Federal Communications Commission (FCC) now has full complement of Commissioners for the first time during the Biden Administration. In September, Anna Gomez was confirmed by the Senate and sworn in to the third FCC Democratic seat. Additionally, current Commissioners Starks and Carr received confirmations to full five-year terms recently.

The big news, though, is that after a period of no real movement on new funding for the Emergency Connectivity Fund (ECF), the FCC is starting to make significant strides towards getting behind some pieces of ECF. They recently approved Wi-Fi on school buses as an eligible E-Rate service. In addition, the Chair is circulating a Notice of Proposed Rulemaking (NPRM) that proposes to make Wi-Fi hotspots and home Internet connections eligible for E-Rate support. Finally, the Commission will likely be issuing soon a separate NPRM on creating a \$200 million, multi-year cybersecurity pilot. ~

About the District: Liberty County School System, located on the southeastern coast of Georgia, is a diverse community, rich in history, serving approximately 10,800 students from all over the world. It is home to the 3rd Infantry Division (3ID) (nicknamed Rock of the Marne), a combined arms division of the United States Army based at Fort Stewart. We have seven elementary schools, three middle schools, two high schools, one pre-k learning center, one college and career academy, and one alternative learning center. We also partner with local colleges and technical schools on dual enrollment programs that allow our students to earn college credits while attending high school. Many earn certifications that allow them to enter the workforce upon graduation. In addition, Liberty County offers opportunities for students to participate in STEAM (Science, Technology, Engineering, Art and Math) programs at all levels throughout the county. We promote a technology-rich environment, providing all students with iPads and interactive flat panels for classroom instruction. Our ESOL student numbers continue to increase, and we provide supports for students in over 13 different languages. Liberty County is a charter system, giving us the flexibility for innovative instructional practices to best meet the needs of our diverse population.



Notably, we have the ability to serve any special education exceptionality, and families often request to be stationed at Fort Stewart. Five of our schools have been recognized by the Georgia Department of Education as Military Flagship Schools for going above and beyond to provide a supportive environment for military students and families.

Importance of Impact Aid: Impact Aid allows us to add to our instructional programs, helping us provide students with the best learning experiences possible. We also use the funds to provide safe and supportive learning environments to our students and staff. While 71% of our students qualify for free and reduced price meals, Impact Aid provides the opportunity for all students to participate in extracurricular activities. In addition, it allows us to provide transportation to all students and additional bus aides to our students with special needs.

With additional funds, we could expand our instructional, enrichment, and student activity programs in support of our vision that **all students will receive a high quality education providing them the knowledge and skills to be successful, contributing members of a global society.**

Service on the NAFIS Board: Serving on the NAFIS Board gives me the opportunity to advocate for all students in Liberty County and better provide resources and experiences to our community. I am excited to join other representatives who strongly advocate to support education for ALL students. ~

Fall Conference Breakout Session Round-Up

Filling Vacancies Amid Teacher Shortages

At the 2023 NAFIS Fall Conference, attendees had the opportunity to learn about and discuss how school districts can brainstorm, develop and implement innovative solutions to growing teacher and educator shortages. Deborah Koolbeck, Federal Lobbyist for the National Education Association (NEA), Billie Jordan, Executive Director of Oklahoma Association Serving Impacted Schools (OASIS), and Joan Wade, Executive Director of the Association of Educational Service Agencies (AESAs) spoke about the effects of teacher shortages that they are observing and offered ideas to creatively fill teacher gaps. Members of the audience also contributed their own personal experiences with the teacher shortage issue.

It is no secret that the COVID-19 pandemic has exacerbated teacher shortages. With teachers exiting and a lack of interest in entering the profession, school districts are continually experiencing the effects of fewer and fewer teachers in classrooms. With growing shortages, teachers are taking on more responsibilities outside of their job description and are forced to handle larger class sizes, all while enduring stagnant wages. To tackle the teacher shortage crisis, panelists highlighted the need to implement evidence-based, long-term strategies to address both recruitment and retention.

license and certification reciprocity, and comprehensive teacher mentoring. Specifically, both panelists and several attendees noted that increasing teacher licensing and certification reciprocity could open teaching opportunities to individuals in many more states.

Koolbeck pointed to an [NEA report](#) highlighting the need to solve educator shortages by making public education an attractive and competitive career path. Examples of long-term solutions that panelists pointed to included grow your own and apprenticeship programs, teacher residencies, student debt relief and forgiveness,

While the outlook on the teaching gap looks bleak as of now, policymakers and education leaders have many long-term, evidence-based strategies to draw from to tackle this crisis. Continually uplifting the teaching profession and making it a desirable career path will help ensure bright individuals continue to join the profession. Additionally, creating the best working conditions possible will help these individuals enjoy long careers as educators. Panelists and attendees all agreed that students deserve teachers who are well-prepared and able to provide one-on-one attention, and filling the teacher gap will help fulfill that. ~

Impact Aid Survey to Application Express

Attendees also had the opportunity to hear from U.S. Department of Education Impact Aid Analysts Chad Eggleston and Nanette Dunham on the annual Section 7003 Impact Aid survey and application. They offered an overview of the survey process and tips to make it a success.

The Impact Aid student count is to be completed between the fourth day of the school year and January 30. School districts should choose the date when student membership is at its highest. Options for conducting the count are a Parent-Pupil Survey, which is sent home for parents to sign, and a Source Check, which certifiers associated with both the school district and the federal property sign to verify

students' enrollment and connection to the property. Some districts may conduct their Parent-Pupil Survey using Electronic Data Collection (EDC); however, before doing so a district needs approval from the EDC Team at the Department Education. However, presenters noted that school districts do not need prior approval to use digital signatures on forms.

Multiple siblings can be included on one Parent-Pupil Survey form, though if any have disabilities they need to have a separate form. Information can be prefilled as long as there is space for parents to make any needed changes. Checkboxes can be used for common properties in the district. The form must be dated and signed on or after the survey date. Presenters also noted that whether they use a Source Check or Parent-Pupil Survey, school districts should keep copies of data collected in case of a monitoring review.

After completing the count, students should be organized by category (such as military on-base or residing on Indian Lands) first and property second, then reported on the application. Applicants should log in to the Impact Aid Grant System (IAGS) regularly to keep their account up to date. To review payment vouchers, they can log in to IAGS, go to the top menu to local educational agencies (LEAs), enter the school district's name, and click payment history. Best Practices From Purple Star Schools

The Purple Star designation recognizes schools that meet certain requirements in providing supports to military students and families, helping them overcome the educational and social and emotional challenges of moving to a new school. This session shared best practices from districts where schools have earned the honor.

Christopher Arnold, Mid-Atlantic Region Liaison for the U.S. Department of Defense - State Liaison Office, began the session with discussion on the characteristics of military-friendly schools. Attendees shared adjectives like engaging, welcoming, inclusive, informed, and working.

Educators then shared examples of how their districts support military students. Jesse Najera, Superintendent of Silver Valley Unified School District (CA) – where all schools have earned Purple Stars – said his district is focused on empowering students to be leaders. He also said Purple Star Schools should be committed to supporting surrounding districts. Central Union Elementary School District (CA) Superintendent Tom Addington discussed flexible online enrollment for military families and creating a welcoming atmosphere, including with red-carpet entries for military students, breakfast initiatives and community night-outs. Hilary Bales, Superintendent of Waynesville R-VI School District (MO), discussed their “Salute to Service”, which honors high school seniors joining the military. Her district offers counselors and teletherapy to support all transitioning students, not just military students. Jeff Hollamon, Chief Financial Officer of

Onslow County Schools (NC), shared his district’s “Chalk the Walk” honoring military students and families and discussed hosting luncheons for veterans employed in their schools.

All panelists agreed that mental health is a priority when military students are transitioning. Hollamon said that recognizing signs of mental health struggles is a key focus of staff development in his district. Addington’s district uses surveys to analyze concerns and strengths of the district from a student perspective.

Panelists also agreed on the need for a good relationship with the school liaison office. Laura Anastasio, Chair of the Military Interstate Children’s Compact Commission (MIC3), expanded on this idea and wrapped up discussion with information on [MIC3 training](#) and professional development programs, including monthly webinars. ~

Supporting Student Mental Health in Rural Schools

During a standing-room only session, Superintendents Deborah Jackson-Dennison (San Carlos Unified School District, AZ) and Stephanie Long (Leland Public School, MI) discussed how their school districts, both located in rural communities, are addressing the youth mental health crisis. The conversation was moderated by Sasha Pudelski, Advocacy Director at AASA, the School Superintendents Association, who also shared federal funding opportunities to help districts meet mental health needs.

Both Long and Jackson-Dennison spoke of the need for trauma-informed schools. Jackson-Dennison did so in the context of Shilgozhóó (which in Apache means in essence, “I am ready to learn”), a community-developed school reform journey that includes ensuring the district is social and emotional learning-centered. She also discussed the need for community partners and reiterated the importance of meeting **all** student needs (for example, her district has laundry facilities students can use).

Long shared her district’s comprehensive strategy to address mental health and wellness through initiatives at the classroom, grade level, building, and district and community levels. She also discussed using a threat assessment rubric to evaluate mental health concerns and identify those at risk of harming themselves or others.

Noting that schools are a key provider of youth mental health services but face many challenges in doing so, including a lack of funds and

a lack of providers, Pudelski shared that school districts may be able to use Medicaid to help support salaries for school mental health professionals and sustain partnerships with community providers and agencies. While historically Medicaid only paid for health services included in the IEPs of students enrolled in Medicaid, a 2014 policy change allows states to choose to expand school-based Medicaid programs to ALL Medicaid-enrolled students.

Pudelski also shared resources to help students dealing with grief - [studentcrisiscenter.org](#) and [grievingstudents.org](#). For districts serving military students, an attendee noted that Military Family Life Consultants are a vital resource, helping service members and families deal with issues such as anxiety, depression and more. ~

Stronger Together: NAFIS Subgroup Leaders on Unity

The NAFIS Family includes four subgroups, each representing an important Impact Aid constituency – Federal Lands Impacted Schools Association (FLISA), Learning Opportunity Impacted Schools Association (LO~ISA), Military Impacted Schools Association (MISA), and National Indian Impacted Schools Association (NIISA). During the fall conference, executive directors of those organizations – Tom Schneider, FLISA; Jim Sarruda, LO~ISA; Kyle Fairbairn, MISA; and Brent Gish, NIISA – participated in a panel discussion sharing the history of their organizations and the perspectives they bring to Impact Aid advocacy and the NAFIS Family.

In addition to highlighting what makes each subgroup unique, the panel emphasized the importance of standing together. Gish pointed out that together we stand, divided we fall, as Pink Floyd famously sang. Schneider noted that legislative success for FLISA is based largely on the success of NAFIS as a whole and stressed the need to build bridges between constituencies. Fairbairn observed that thanks to continuity on the NAFIS Board, individuals have the opportunity to work together for many years and develop the trust that is key to moving forward in ways that benefit the entire NAFIS community. Sarruda noted the intentional effort to ensure diversity on the NAFIS Board in terms of subgroup affiliation and pointed to how in times of threat to Impact Aid, even when the threat is only to one constituency, the entire community gels together in support of the program.

While there have been and always will be differences and disagreements between the NAFIS subgroups, this discussion made clear that these individuals and the organizations they lead are committed to standing together to benefit the entirety of the Impact Aid population. As we celebrate 50 years of NAFIS, we look forward to many more years of partnership and shared success. ~

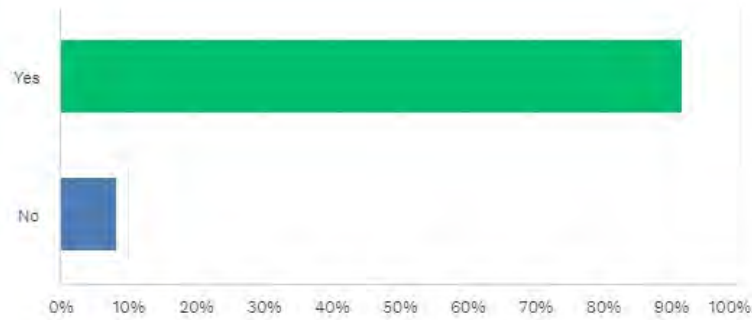

Attendees Share Feedback on 2023 NAFIS Fall Conference

The 2023 Fall Conference welcomed almost 400 guests to the Hyatt ballroom for the NAFIS 50th anniversary celebration. Of those attendees, 73 responded to our survey, with 91% finding the conference material to be useful in their work. Many noted that they appreciated the positive environment, interesting content, and engaging keynote speakers. One respondent commented that the conference was “Well planned and all sessions brought valuable information and insights. Thank you for the investment of time, energy, and fiscal resources to make this event valuable”. Another wrote, “This was my first conference and everything was extremely helpful”.

Did the conference cover material that will be useful in your work?



Attendees raved about Monday’s keynote, with 99% of respondents scoring educator Michael Bonner as “excellent”. Another highly rated session was the breakout on supporting student mental health in rural school districts, which got universally positive feedback. One participant said, “The breakout I attended on Monday on mental health supports was AWESOME!! We need more like that where we can take pieces and parts and apply them back at our own district”.

NAFIS takes a data-informed approach to conference planning, using evaluation results to develop programming. We invite keynote speakers who offer motivational presentations based on previous conference feedback, and we included a breakout on student mental health at this conference for the same reason. The results from this event’s survey indicate that attendees would like to hear more from fellow Impact Aid districts on best practices and strategies that work in communities across the country. Other topics suggested include special education, Native relationships, and a deeper dive into conducting effective Hill meetings.

More than 90% of respondents rated the conference registration website as “excellent” or “good”. Many showed appreciation for the con-

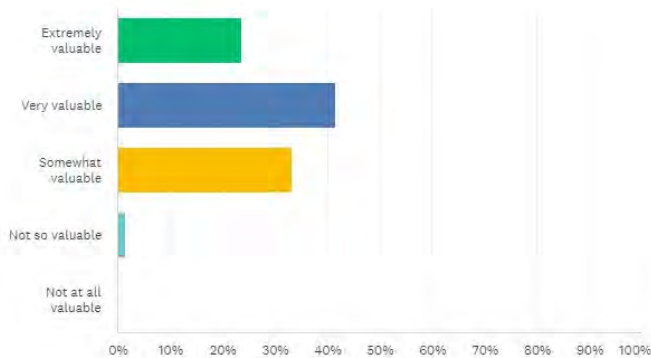

We asked NAFIS members how a delay in receiving Impact Aid funding would affect their school district. Here are some of the answers:

With Impact Aid making up around 25% of the school budget, our district would not be able to purchase new technology or textbooks for updated curriculum without the funding.
- Superintendent, North Dakota

Due to a COVID-era change, our district lost three times the funds we expected to lose after a monitoring review. Now we must receive Impact Aid on time, as we have already gotten less than budgeted this year.
- Finance Director, Alaska

For our district delayed funding “will impact everything”. Vital construction projects in the district would have to be put on hold to redistribute funds to pay teacher salaries.

These Members of Congress have each served as a leading voice in strengthening and protecting Impact Aid in the face of many challenges over the course of decades.

Senator Patty Murray (D-WA) was first elected in 1993, and she recognized the importance of Impact Aid early in her tenure. She helped found the Senate Impact Aid Coalition, which she now co-chairs, in 1996. Over her three decades in the Senate, she has advocated for the program in a number of ways, including as Chair of the Budget Committee during the 113th Congress, when Impact Aid and other education programs were faced with massive budget cuts. In addition, as Chair of the Senate Appropriations Subcommittee on Labor, Health and Human Services, and Education, she ensured Impact Aid saw sizeable increases.



When **Senator John Thune (R-SD)** (pictured to left receiving the award and a dreamcatcher from *Impact Schools of South Dakota (ISSD)* from South Dakota students *Ridley Zajic and Braxton Yackley*) won his first term as South Dakota's member of the U.S. House of Representatives in 1996, he became an early member of the House Impact Aid Coalition. He joined the Senate Impact Aid Coalition, which he currently co-chairs, after being elected to the chamber in 2004. Among his many accomplishments in support of Impact Aid, Senator Thune played a key role in simplifying and modernizing the Section 7002 Federal Property payment formula. He also served as the Republican lead on the Impact Aid Coronavirus Relief Act and Supplemental Impact Aid Flexibility Act, both of which allowed flexibility to school districts on Impact Aid applications in the wake of COVID-19, providing critical stability in school funding during an uncertain time.

Currently serving in his tenth term in the U.S. House of Representatives, **Representative Tom Cole (R-OK-04)** has served on the House Appropriations Committee since 2009 and is currently Vice Chair of the full committee. For many years, he served on the Appropriations Subcommittee on Labor, Health and Human Services, and Education, including as Chair and Ranking Member. In those positions, Rep. Cole consistently prioritized the Impact Aid Program and secured needed funding for it. He is an original co-sponsor of the Advancing Toward Impact Aid Full Funding Act in the 118th Congress, and he is a longstanding member of the House Impact Aid Coalition.

A founding member of the House Impact Aid Coalition in 1995, **Representative Bobby Scott (D-VA-03)** (pictured to right receiving the award from *NAFIS Executive Director Nicole Russell*) currently serves on its Steering Committee. In the 118th Congress, he serves as Ranking Member of the Committee on Education and the Workforce, his fifth term as the Committee's Democratic leader. As Chair of the Committee during the 116th and 117th Congresses, he helped lead passage of the American Rescue Plan, which provided a historic investment in public schools to help them reopen safely and make up for lost learning time, among other important legislation. Committed to school infrastructure – a critical need for federally impacted school districts – Rep. Scott has led introduction of the Rebuild Americas Schools Act in multiple Congresses. This legislation includes significant investment in the Impact Aid Construction program.

The entire Impact Aid community joins together in thanking our Golden Champions for their longstanding support of Impact Aid and leadership in meeting the needs of federally impacted school districts and the students they serve. ~

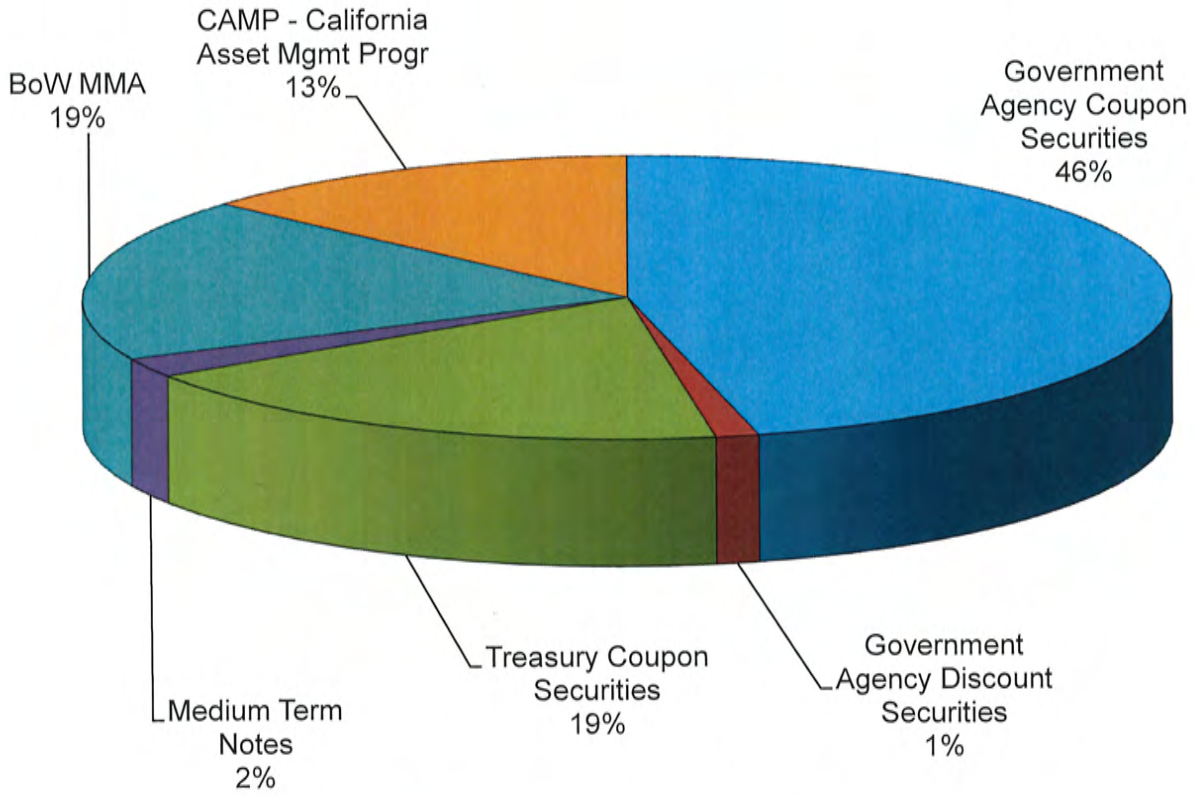

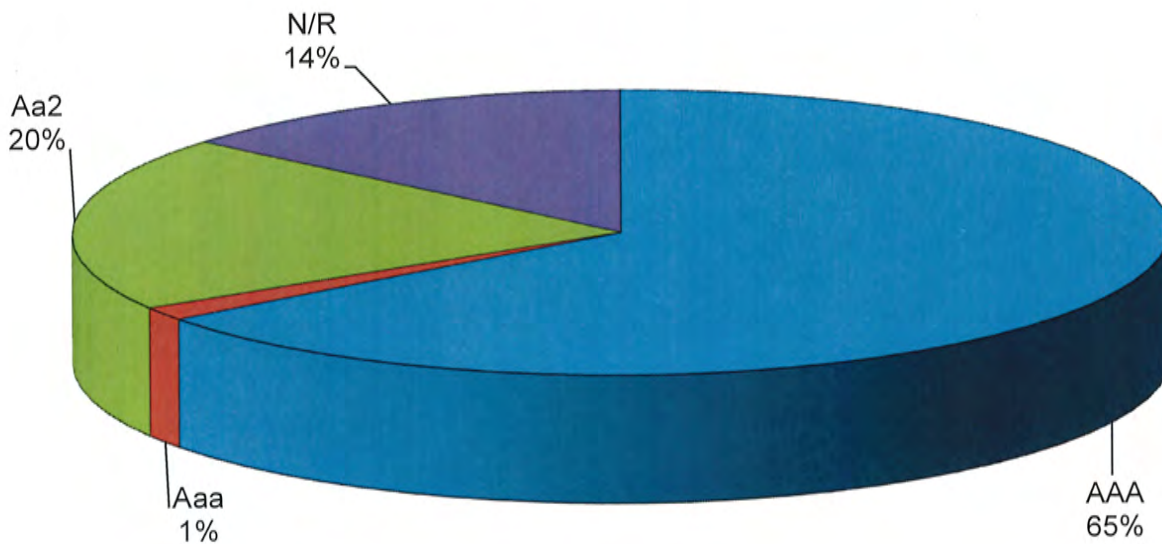



- Hummus (serve with vegetables or whole grain crackers)

- Roll-ups on whole grain tortillas (fill with a lean protein such as ham or turkey, low fat cheese, hummus, and jelly or vegetables)
- Fat-free or low fat pudding
- Bean quesadillas or burritos made with whole grain tortillas with salsa
- Whole grain cereal bars
- Baked whole grain tortilla chips with salsa or bean dip
- Baked chips (small portions)

The proposed survey would include a pre-renovation survey of suspect asbestos-containing building materials at interior and exterior locations at above building site selected by you. We also propose to provide a lead-based paint inspection in accordance with State of California requirements under Title 17, Div. 1, Chapter 8.

The proposed scope by phase follows:

Asbestos Survey and Lead-Based Paint Inspection

Asbestos Survey

We propose to conduct representative samples of suspect asbestos-containing building materials at interior and exterior locations to be impacted by the proposed renovation operations involving the above referenced school property and prepare a report which consolidates the data and our findings. The proposed survey would be conducted in compliance with the requirements of 40 CFR Part 61 subpart "M" (NESHAP), the San Joaquin Valley Air Pollution Control District, and Cal/OSHA regulations (8 CCR 1529).

The survey report would include the following elements:

1. Document sampling locations on a floor plan
2. A copy of laboratory analysis of bulk samples collected at the subject site
3. Recommendations in keeping with applicable local, state, and federal regulations
4. Quantification of materials testing positive for asbestos content

Supplemental Bulk Sample Analytical Cost – Point-Count Analysis

Suspect asbestos-containing materials will be analyzed by Polarized Light Microscopy (PLM). The proposed cost does not include costs related to additional analysis by "Point-Count Method" as allowed under the NESHAP regulation to accurately determine asbestos content.

Point-count analysis will be provided for additional cost of **\$45.00 per sample as authorized by the Client**. The turn-around time for the point-count analysis would be 2-3 days. Point-count analysis is appropriate in those cases where asbestos is found in building materials at a concentration of less than 10%. Under the NESHAP, the material can be assumed to be

5. Client agrees not to reuse Work Product, in whole or in part, for any project other than the project that is the subject of this agreement. Client further agrees to waive all claims against Consultant resulting in any way from any unauthorized changes or unauthorized reuse of the Work Product for any other project by anyone on Client's behalf. Client agrees not to use or permit any other person to use versions of Work Product which are not final and which are not signed and stamped or sealed by Consultant. Client shall be responsible for any such use of non-final Work Product. Client hereby waives any claim for liability against Consultant for use of non-final Work Product. If a reviewing agency requires that check prints be submitted with a stamp or seal, those shall not be considered final for purposes of this paragraph.
6. In the event Client (1) makes, agrees to, authorizes, or permits changes in Work Product, or (2) makes, agrees to, authorizes, or permits construction of such unauthorized changes, which changes are not consented to in writing by Consultant, or (3) does not follow recommendations prepared by Consultant pursuant to this agreement, resulting in unauthorized changes to the project, Client acknowledges that the unauthorized changes and their effects are not the responsibility of Consultant. Client agrees to release Consultant from all liability arising from such unauthorized changes, and further agrees to defend, indemnify and hold harmless Consultant, its officers, directors, employees and subconsultants from and against all claims, demands, damages or costs, including attorneys' fees, arising from such changes.
7. Under no circumstances shall delivery of Work Product for use by the Client be deemed a sale by the Consultant, and the Consultant makes no warranties, either express or implied, of merchantability and fitness for any particular purpose. In no event shall the Consultant be liable for indirect or consequential damages as a result of the Client's unauthorized use or reuse of the Work Product.
8. The Client is aware that differences may exist between electronic files delivered and the printed hard-copy construction documents. In the event of a conflict between the signed construction documents prepared by the Consultant and electronic files, the signed sealed hard-copy documents shall govern.

LIMITATIONS

9. Consultant makes no representations concerning soils or geological conditions unless specifically included in writing in this agreement, or by amendments to this agreement. If Consultant recommends that Client retain the services of a Geotechnical Engineer and Client chooses to not do so, Consultant shall not be responsible for any liability that may arise out of the making of or failure to make soils or geological surveys, subsurface soils or geological tests, or general soils or geological testing.
10. Client acknowledges that, unless specifically stated to the contrary in the proposal's description of services to be provided, Consultant's scope of services for this project does not include any services related in any way to asbestos and/or hazardous or toxic materials. Should Consultant or any other party encounter such materials on the job site, or should it in any other way become known that such materials are present or may be present on the job site or any adjacent or nearby areas which may affect Consultant's services, Consultant may, at its option, suspend or terminate work on the project until such time as Client retains a qualified contractor to abate and/or remove the asbestos and/or hazardous or toxic materials and warrant that the job site is free from any hazard which may result from the existence of such materials.

INDEMNIFICATION

11. To the fullest extent allowed by law, Consultant will indemnify and hold harmless, but shall have no duty to defend Client, its officers, directors, employees, and agents (collectively, the "Client indemnities") from, for and against any and all claims, demands, damages, losses, expenses, liabilities, and penalties arising out of or relating to the Project, but only to the extent caused by the negligent or other wrongful acts or omissions of Consultant, its subconsultants, or any person or entity for whose acts or omissions any of them are responsible, or by the failure of any such party to perform as required by this Agreement. To the fullest extent allowed by law, Client will indemnify and hold harmless, but shall have no duty to defend Consultant and its officers, directors, employees and agents from, for and

against any and all claims, demands, damages, losses, expenses, liabilities and penalties arising out of or relating to the Project, but only to the extent caused by the negligent or other wrongful acts or omissions of Client or any person or entity for whose acts or omissions it is responsible, or by the failure of any such party to perform as required by this Agreement. The obligations and rights of this Section are in addition to other obligations and rights of indemnity provided under this Agreement or applicable law.

FINANCIAL

12. All fees and other charges due Consultant will be billed monthly and shall be due at the time of billing unless specified otherwise in this agreement. If Client fails to pay Consultant within sixty (60) days after invoices are rendered, Consultant shall have the right in its sole discretion to consider such default in payment a material breach of this entire agreement, and, upon written notice, Consultant's duties, obligations and responsibilities under this agreement may be suspended or terminated for cause pursuant to Sections 26 through 31. In such event, Client shall promptly pay Consultant for all outstanding fees and charges due Consultant at the time of suspension or termination including all costs and expenses incurred in the performance of services up to suspension or termination.
13. Consultant shall not be liable to Client for any costs or damages that may result from the termination or suspension of services under this agreement due to Client's failure to pay Consultant invoices in accordance with the terms of this paragraph. In the event that Consultant agrees to resume terminated or suspended services after receiving full payment of all late invoices, Client agrees that time schedules and fees, as applicable, related to the services will be equitably adjusted to reflect any delays or additional costs caused by the termination or suspension of services.
14. In all cases where the proposal calls for payment of a retainer, that payment shall be made by Client to Consultant prior to commencement of services under this agreement. Upon receipt of retainer payment, the Consultant shall commence services as provided for under this Agreement. Unless otherwise provided for in the project proposal, such retainer shall be held by Consultant throughout the duration of the contract, and shall be applied to the final project invoice, and to any other outstanding AR, including late payment charges, on the project. Any amount of said retainer in excess of the final invoice and other outstanding AR shall be returned to the Client within 30 days of issuance of the final project invoice.
15. Client agrees that all billings from Consultant to Client will be considered correct and binding on Client unless Client, within ten (10) days from the date of receipt of such billing, notifies Consultant in writing of alleged inaccuracies, discrepancies, or errors in billing. In the event of a dispute over any billing or portion of billing, Client agrees to pay the undisputed portion of any billings in accordance with the payment terms set forth in Section 12.
16. Client agrees to pay a monthly late payment charge, which will be the lesser of one and one half percent (1-1/2%) per month or a monthly charge not to exceed the maximum legal rate, which will be applied to any unpaid balance commencing thirty (30) days after the date of the billing. Client acknowledges that payments applied first to unpaid late payment charges and then to unpaid balances of invoices.
17. In the event Consultant's fee schedule changes due to any increase of costs such as the granting of wage increases and/or other employee benefits to field or office employees or any taxes or fees imposed by local, state, or federal government on consultants' fees during the lifetime of this agreement, the new fee schedule shall apply to all subsequent work on time-and-materials contracts.
18. If payment for Consultant's services is to be made on behalf of Client by a third party lender, Client agrees that Consultant shall not be required to indemnify the third party lender, in the form of an endorsement or otherwise, as a condition to receiving payment for services. Client agrees to reimburse Consultant for all collection agency fees, legal fees, court costs, reasonable consultant staff costs and other expenses paid or incurred by Consultant in the event that collection efforts become necessary to enforce payment of any unpaid billings due to Consultant in connection with the services provided in this agreement.

LIMITATION OF LIABILITY

19. **Notwithstanding any other provisions of this Agreement to the contrary, the aggregate liability of the Consultant under this Agreement, whether for breach of contract, tort, strict liability or any other legal theory, will not exceed the total amount of Consultant's compensation for performing services under this Agreement or \$50,000, whichever is greater, however this limitation of Consultant's liability does not apply to third-party claims, or to the Client's reasonable attorneys' fees and expert witnesses' fees and litigation expenses arising out of or related to such third-party claims for which Consultant is liable.**

DISPUTE RESOLUTION

20. In an effort to resolve any conflicts or disputes that arise regarding performance under this agreement by either party, Client and Consultant agree that all such disputes shall be submitted to nonbinding mediation, using a mutually agreed upon mediation services experienced in the resolution of construction disputes. Unless the parties mutually agree otherwise, such mediation shall be a pre-condition to the initiation of any litigation. The parties further agree to include a similar mediation provision in their agreements with other independent contractors and consultants retained for the project and require them to similarly agree to these dispute resolution procedures. This provision shall not be interpreted to restrict the right of either party to file an action in a court of law, in the County of Fresno, State of California, having appropriate jurisdiction or to preclude or limit the Consultant's right to record, perfect or to enforce any applicable lien or Stop Notice rights.

CONSTRUCTION PROJECTS

21. If the scope of services contained in this agreement does not include construction phase services for this project, Client agrees that such construction phase services will be provided by Client or by others. Client assumes all responsibility for interpretation of the contract documents and for construction observation and supervision and waives any claim against Consultant that may in any way be connected thereto. In addition, Client agrees to indemnify and hold Consultant harmless from any loss, claim, or cost, including reasonable attorneys' fees and costs of defense, arising or resulting from the performance of such services by other persons or entities and from any and all claims arising from the modification, clarification, interpretation, adjustments or changes made to the contract documents to reflect changed field or other conditions, except for claims arising from the negligence or other wrongful acts of Consultant, its employees, its subconsultants, or any other person or entity for which Consultant is responsible.
22. Client agrees to include provisions in its contract with the construction contractor to the effect that in accordance with generally accepted construction practices, the construction contractor will be required to assume sole and complete responsibility for job site conditions during the course of construction of the project, including safety of all persons and property, and that this requirement shall apply continuously and not be limited to normal working hours. Neither the professional activities of Consultant nor the presence of Consultant or its employees or subconsultants at a construction site shall relieve the contractor and its subcontractors of their obligations, duties and responsibilities including, but not limited to, construction means, methods, sequence, techniques or procedures necessary for performing, superintending or coordinating all portions of the work of construction in accordance with the contract documents and applicable health or safety requirements of any regulatory agency or of state law.
23. Client agrees to require its contractor and subcontractors to review the plans, specifications and documents prepared by Consultant prior to the commencement of construction phase work. If the contractor and/or subcontractors believe there are deficiencies, conflicts, errors, omissions, code violations, or other deficiencies in the plans, specifications and documents prepared by Consultant, contractors shall notify Client so those deficiencies may be corrected or otherwise addressed by Consultant prior to the commencement of construction phase work.
24. If, during the construction phase of the project, Client discovers or becomes aware of changed field or other conditions which necessitate clarifications, modifications or other changes to the plans, specifications, estimates or other documents prepared by Consultant, Client agrees to notify Consultant and, at Client's option, retain Consultant to prepare the necessary changes or modifications before construction activities proceed. Further, Client agrees to require a provision in its construction contracts for the project which requires the contractor to promptly notify Client of any changed field or other conditions so that Client may in turn notify Consultant pursuant to the provisions of this paragraph.
25. If, due to the Consultant's error, omission or negligence, a required item or component of the Project is omitted from the Consultant's construction documents, the Consultant shall not be responsible for paying the cost required to add such item or component to the extent that such item or component would have been required and included in the original construction documents. The Consultant will not be responsible for any cost or expense that enhances the value of the Project.

SUSPENSION AND TERMINATION

26. If the Project or the Consultant's services are suspended by the Client for more than thirty (30) consecutive calendar days, the Consultant shall be compensated for all services performed and reimbursable expenses incurred prior to the receipt of notice of suspension. In addition, upon resumption of services, the Client shall compensate the

- Consultant for expenses incurred as a result of the suspension and resumption of its services, and the Consultant's schedule and fees for the remainder of the Project shall be equitably adjusted.
27. If the Consultant's services are suspended for more than ninety (90) days, consecutive or in the aggregate, the Consultant may terminate this Agreement upon giving not less than five (5) calendar days' written notice to the Client.
 28. If the Client is in breach of the payment terms or otherwise is in material breach of this Agreement, the Consultant may suspend performance of services upon five (5) calendar days' notice to the Client. The Consultant shall have no liability to the Client, and the Client agrees to make no claim for any delay or damage as a result of such suspension caused by any breach of this Agreement by the Client. Upon receipt of payment in full of all outstanding sums due from the Client, or curing of such other breach that caused the Consultant to suspend services, the Consultant shall resume services, and there shall be an equitable adjustment to the remaining project schedule and fees as a result of the suspension.
 29. Client acknowledges Consultant has the right to complete all services included in this agreement. In the event this agreement is terminated before the completion of all services, unless Consultant is responsible for such early termination, Client agrees to release Consultant from all liability for services not performed or completed by Consultant and from liability for any third-party reliance, use, interpretation or extrapolation of Consultant's work product. In the event all or any portion of the services by Consultant are suspended, abandoned, or otherwise terminated, Client shall pay Consultant all fees and charges for services provided prior to termination, not to exceed the contract limits specified herein, if any. Client acknowledges if the project services are suspended and restarted, there will be additional charges due to suspension of the services which shall be paid for by Client as extra services pursuant to Section 26. Client acknowledges if project services are terminated for the convenience of Client, Consultant is entitled to reasonable termination costs and expenses, to be paid by Client as extra services pursuant to Section 31.
 30. The Client may terminate this Agreement for the Client's convenience and without cause upon giving the Consultant not less than seven (7) calendar days' written notice.
 31. In the event of termination of this Agreement by either party, Consultant shall invoice Client for all outstanding services and expenses reasonably incurred by the Consultant in connection with the orderly termination of this Agreement, including but not limited to demobilization, reassignment of personnel, associated overhead costs and all other expenses directly resulting from the termination. The Client shall within thirty (30) calendar days of termination pay the Consultant for all services rendered and all reimbursable costs incurred by the Consultant up to the date of termination, in accordance with the payment provisions of this Agreement.


OTHER

32. This agreement shall be binding upon the heirs, executors, administrators, successors and assigns of Client and Consultant.
33. This agreement shall not be assigned by either Client or Consultant without the prior written consent of the other.
34. Consultant's or Client's waiver of any term, condition or covenant shall not constitute the waiver of any other term, condition or covenant. Consultant's or Client's waiver of any breach of this agreement shall not constitute the waiver of any other breach of the Agreement.
35. Client and Consultant agree that if any term or provision of this Agreement is determined to be illegal, in conflict with any law, void or otherwise unenforceable, and if the essential terms and provisions of this Agreement remain unaffected, then the validity of the remaining terms and provisions will not be affected and the offending provision will be given the fullest meaning and effect allowed by law.
36. This agreement shall be governed by and construed in accordance with the laws of the State of California. The Client agrees and consents to the exclusive jurisdiction of the courts of the State of California for all purposes regarding this Agreement and further agrees and consents that venue of any action brought hereunder shall be exclusively in the County of Fresno, State of California.
37. Within the limits of the approved scope and fee, Consultant may engage the services of any subconsultants when, in the Consultant's sole opinion, it is appropriate to do so. Such subconsultants may include testing laboratories, geotechnical engineers and other specialized consulting services deemed necessary by the Consultant to carry out the scope of the Consultant's services.

- 38. Consultant shall be entitled to immediately, and without notice, suspend the performance of any and all of its obligations pursuant to this agreement if Client files a voluntary petition seeking relief under the United States Bankruptcy Code or if there is an involuntary bankruptcy petition filed against Client in the United States Bankruptcy Court, and that petition is not dismissed within fifteen (15) days of its filing. Any suspension of services made pursuant to the provisions of this paragraph shall continue until such time as this agreement has been fully and properly assumed in accordance with the applicable provisions of the United States Bankruptcy Code and in compliance with final order or judgment issued by the Bankruptcy Court.
- 39. This agreement shall not be construed to alter, affect or waive any design professional's lien, mechanic's lien or stop notice right, which Consultant may have for the performance of services pursuant to this agreement. Client agrees to provide to Consultant the current name and address of the record owner of the property upon which the project is to be located. Client also agrees to provide Consultant with the name and address of any and all lenders who may loan money on the project and who are entitled to receive a preliminary notice.
- 40. Consultant shall not be liable for damages resulting from the actions or inactions of governmental agencies including, but not limited to, permit processing, environmental impact reports, dedications, general plans and amendments thereto, zoning matters, annexations or consolidations, use or conditional use permits, project or plan approvals, and building permits. Client agrees that it is the responsibility of Client to maintain in good standing all governmental approvals or permits and to timely apply for any necessary extensions thereof.
- 41. Consultant and Client each agree to waive consequential damages for claims, disputes or other matters in question arising out of or relating to this Agreement. This mutual waiver is applicable, without limitation, to all consequential damages due to either party's termination in accordance with paragraphs 26 through 31, except for termination expenses provided for in said paragraph 31. Client further agrees that to the fullest extent permitted by law, Consultant shall not be liable to Client for any special, indirect or consequential damages whatsoever, whether caused by Consultant's negligence, errors, omissions, strict liability, breach of contract, breach of warranty or other cause or causes whatsoever, including but not limited to, loss of use of equipment or facility, and loss of profits or revenue.
- 42. This Agreement is the entire Agreement between the Client and the Consultant. It supersedes all prior communications, understandings and agreements, whether oral or written. Amendments to this Agreement must be in writing and signed by both the Client and the Consultant.

Approval of Indian Policies and Procedures (IPP) BP 6173.5

Rationale/Purpose:

The Central Union Elementary School District annually reviews and modifies the Indian Policy and Procedures (IPPs) based upon the results of any assessment or input received through the process outlined within the policy. Once the policy is updated with federal requirements, and recommendations from the Indian Education Council and Parents of every Native American student that resides on the Santa Rosa Rancheria are received and reviewed, it is then forwarded to the Central Union School District Board of Trustees for approval.

Fiscal Impact:

The Central Union Elementary School District attests that it has established IPP as required in Section 7004 of the Impact Aid law for any children who reside on eligible Indian lands.

Recommendation:

This policy has been reviewed and updated as required in Section 7004 of the Impact Aid law for any children who reside on eligible Indian lands. In the review of IPP BP 6173.5 there were no ideas or suggestions received regarding the policy. A feedback form in regards to the IPP was disseminated to Parents of every Native American student that resides on the Santa Rosa Rancheria ; posted on the District and School Web pages; and communicated with a global phone call to all parents of Indian children who are living on the Santa Rosa Rancheria. Therefore, it is recommended that the policy be approved for the 2022-2023 school year.

Policy 6173.5: Indian Policies and Procedures

Status: ADOPTED

Original Adopted Date: 05/09/1988 | **Last Revised Date:** 11/14/2022 | **Last Reviewed Date:** 11/14/2022

It is the intent of the Central Union Elementary School District that all students of school age in the District have equal access to all programs, services and activities offered. To this end, the Central Union Elementary School District will consult with local tribal officials and parents of Indian children to ensure that the planning and development of the Indian Policies and Procedures (IPPs), ensure that Indian Children have equal access to general education programs, and activities.

These policies and procedures will be reviewed annually and revisions will be made within 90 days of the determination that requirements are not being adequately met.

The Central Union Elementary School District attests that it has established IPPs as required in Section 7004 of the Impact Aid law for any children who reside on eligible Indian lands. The IPPs have been adequately disseminated to the tribes and parents of children residing on eligible Indian lands. A copy of the current policies and procedures are attached to the current fiscal year Impact Aid application.

The Central Union Elementary School District attests that it has provided a copy of written responses to comments, concerns and recommendations received from tribal leaders and parents of Indian children as outlined in the IPP consultation process and disseminated these responses consistent with the process of communication as addressed in the IPP prior to the submission of the current fiscal year Impact Aid application.

The Tachi-Yokut Tribal leadership has established the Santa Rosa Rancheria (SRR) Indian Education Department as the Tribe's designee and liaison for communication and connection with the Central Union Elementary School District. The administrator of the SRR Education Department acts on behalf of and is responsible to the Tribal council and officials for education related matters.

The following policies and procedures are implemented to reflect the current practice of communication with the Tachi-Yokut Tribe.

1. The Central Union Elementary School District will disseminate relevant applications, evaluations, program plans and information related to the education program and activities with sufficient advance notice to allow the Tachi-Yokut Tribe and parents of Indian children the opportunity to review and make recommendations. [34CFR222.94(a)(1)].
 - a. The Central Union Elementary School District will disseminate information and seek timely input regarding the following programs on its educational programs in which Indian children participate (including, but not limited to, as appropriate): Title I, Part A; Title I, Part C; Title I, Part D; Title II, Part A; Title III, Part A; Title IV, Part A; Title IV, Part B; Title V, Part B subpart 2; Title VI, Part A, subpart 1; Title VII-Impact Aid programs; Johnson O'Malley programming.
 - b. The Central Union Elementary School District will discuss relevant applications, evaluations, and program planning during scheduled meetings of the Indian Education Council (IEC). The IEC, which is open to all members of the community, is comprised of nine (9) standing/voting council members, and one (1) nonvoting District representative.
 - i. Three (3) voting members in at large seats and one (1) alternate for parents of Indian Children
 1. The alternate will serve in the capacity of the regular member in case of absence or termination of IEC voting member
 - ii. Two (2) Indian students
 - iii. One (1) school site administrator
 - iv. One (1) school employee/teacher
 - v. Two (2) tribal employees of the SRR Education Department

- vi. One (1) District representative (nonvoting participant)
 - c. Agendas for the IEC meetings are posted at the Central Union Elementary School Site, the Lemoore High School District Office, and the SRR Education Department. These notices are posted 72 hours in advance. In addition, the IEC notice of meetings are posted on school websites, and a global phone message is sent to all parents of Indian students in advance of the IEC meeting.
 - d. A summary of the relevant information will be made available to parents of Indian children, Tribal officials, and the IEC. The summary will be posted on the school website and an automated phone messaging system will be delivered to the respective groups listed above. The summary of relevant information will be prepared one week in advance of IEC Meetings held in September and October.
 - e. Parents of Indian children, tribal officials, IEC and any other interested persons can review assessment data and services regarding participation of Indian students on an equal basis in the district in order to help develop or modify educational programs.
 - f. Minutes from the IEC meetings will be posted on the District's website for all community members, parents of Indian children, and Tribal officials to review. This will allow for ongoing dissemination of information.
2. The Central Union Elementary School District will provide an opportunity for the Tachi-Yokut Tribe and parents of Indian children to provide their views on the District's educational program and activities, including recommendations on the needs of their children and on how the District may help those children realize the benefits of the educational programs and activities. [34CFR222.94(a)(2)]
- a. The IEC of Central Union Elementary School District will meet a minimum of seven (7) times (Sept, Oct, Nov, February, March, April, May) during the school calendar year for the purpose of addressing comments and concerns of parents of Indian children regarding the District's educational programs and activities. Additional meetings will be scheduled as needed in order to review data and comments for consideration of educational programs and activities.
 - b. The meeting agendas are posted and all meetings are open to the public, to afford tribal officials, representatives of the IEC who are appointed to carry out the desires of the Tribal Officials in educational affairs, as well as parents of Indian children, the opportunity to give comments and recommendations for consideration relative to educational programs and activities.
 - c. The District Superintendent or designee, will participate as a non-voting member of the IEC. This District representation provides for discussion and communication regarding educational program offerings to students, as well as allows for dialogue between the District and the IEC representative body.
 - d. Monthly, during regularly scheduled school board meetings, District reports and information are provided from District Administration to the School Board. During these regular agenda items, the District Superintendent or designee, may advise the Board in a public forum regarding District educational programs and activities for Indian students as appropriate.
 - e. In addition, at each of the monthly school board meetings, a section of time is set aside for public comments. This is a time in which members of the public can bring forth comments and suggestions regarding programming for all students.
 - f. The SRR Education Department officials maintain regular contact with parents of Indian children. This is accomplished through SRR tribal employees who are assigned as liaisons to monitor and work with Indian students. The SRR Education Department Liaisons oversee all tribal students and provide parents of Indian students with weekly updates on student's grades, attendance, school behavior and social needs. Each SRR Liaison is closely associated with the Indian student and family. The SRR Liaison attends all meetings scheduled for the Indian student in which educational program decisions may be made. Through this regular contact, the SRR Liaison serves as a conduit for gathering suggestions, preferred methods of communication as well as ways to maximize participation from parents of Indian children. This information is shared with the SRR Education Department Officials and translated into discussion items, which are shared during regularly IEC meetings. Through this intricate system of support for the Indian student, the SRR Education Department operates a model program for other tribes. Input from these connections will also be utilized as a method of During the of gathering input from parents of

Indian children and incorporated into policy changes as appropriate. (See Exhibit 5136).

- g. Information will be included in student handbooks/enrollment packets regarding opportunities to provide input to the District.
3. The Central Union Elementary School District will annually assess the extent to which Indian children participate on an equal basis with non-Indian children in the District's education program and activities. [34CFR222.94(a)(3)], share relevant information related to Indian children's participation in the District's education programs and activities; and allow tribes and parents of Indian children the opportunity and time to review and comment on whether Indian children participate on an equal basis with non-Indian children.

The Central Union Elementary School District will take the following measures to annually assess the extent to which Indian children participate on an equal basis with non-Indian children in the District's education program and activities.

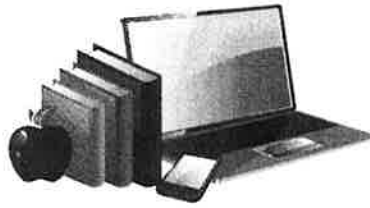
- a. Throughout the school year, the Central Union Elementary School District will monitor Indian student participation in all academic and co-curricular activities. The IEC will review the comprehensive analysis of the yearlong data during the April meeting with the intent to provide the opportunity for consultation and/or recommendation on program participation and modification.
 - b. School district officials will review school data to assess the extent of Indian children's participation in the District's educational programs on an equal basis. This information will be regularly presented following each trimester of the Central Union School Year (November, March, and May).
 - c. The Central Union Elementary School District will share its assessment of Indian student participation; related academic achievements and other relevant data during regular meetings of the IEC and with the SRR Education Department. Comments and/or suggestions brought forth from these conversations will become part of the Council's approved minutes
 - d. Participation rates of students in educational activities is collected annually for all students, inclusion of percentage rates of Indian students will be added to this report to review the equality of Indian children's participation with other children
 - e. Copies of annual reports will be provided to the SRR Education Department for distribution among tribal officials, and will be included in the school websites.
 - f. Parents of Indian children or tribal officials may comment on the results at scheduled IEC meetings, during the public comment section of any regularly scheduled school board meetings, or directly to the school district (by phone, email, writing, etc.).
 - g. In addition, parents of Indian children and tribal officials may comment in the spring semester through the District's annual Local Control Accountability Plan (LCAP) parent survey. The LCAP parent survey is used to develop District short and long term goals associated with District educational plans.
 - h. If it is determined that there are gaps in Indian participation in the educational program or activities, the Central Union Elementary School Board with consultation from the IEC and SRR Education Department will recommend modifications to the education program in such a way as to improve Indian participation.
4. The Central Union Elementary School District will modify the IPPs if necessary, based upon the results of any assessment or input described in this document. [34CRF222.94(a)(4)]
- a. During the Fall (September) meeting of the IEC, the IPPs will be reviewed and revised as necessary.
 - b. The IEC shall serve as the group to review the meaningfulness of Indian input, to review the extent of opportunity for Indian input and to review the District's response to Indian commentary. The IEC will review the effectiveness of the District's methods of gathering the input of Indian parents and Tribal members; calculate the number of Indian suggestions, which were actually implemented; permit Indian parents and Tribal officials to suggest more effective ways of communicating their views.
 - c. If necessary, the IEC shall make recommendations to the Board to modify the District's IPPs.

- d. Once this has occurred, the IPPs will be forwarded to the Central Union Elementary School Board for review and consideration of adoption during a regularly scheduled Board Meeting (no later than November).
 - e. If necessary, the IEC may suggest revisions at other times of the year as appropriate.
 - f. Notification of any updates which are acted upon and approved by the Central Union School Board will be sent to the SRR Education Department for distribution among tribal officials and parents of Indian children.
 - g. Following any review or modification of the IPPs, the Central Union School District shall post updates on the District website.
5. The Central Union Elementary School District will respond at least annually in writing to any comments and recommendations made by the Tachi-Yokut tribe or parents of Indian children, and disseminate the responses to the tribe and parents of Indian children prior to the submission of the IPPs by the LEA. [34CRF222 .94(a)(5)]
- a. The Central Union Elementary School District will at least annually respond in writing to comments and recommendations made by the IEC, tribal officials, or parents of Indian children. In the event community responses, the District will disseminate the reply to the SRR Education Department. As the acting Liaison between the Central Union School District, and the Tachi-Yokut Tribe, the SRR Education Department will submit the District responses to the tribal officials. Additionally, the District will post the District responses on the school website and will send notification of this posting to all parents via the Districts automated telephone notification system.
6. The Central Union Elementary School District will annually provide a copy of the IPPs to the affected Tachi-Yokut tribe by posting on the District website, providing a copy to the SRR Education Department for distribution to the tribal offices, and through inclusion in the District's annual notice packets which are distributed to all parents at the beginning of each school year. [34CR F222.94(a)(6)]

The parties agree as follows:

1. Both parties are responsible for compliance with USDA and the California Department of Education, Nutrition Services Division policies and regulations.
2. Member District agrees to abide by the current SJVPC By-Laws as approved by the Member Districts.
3. Member District shall read all correspondence from the SJVPC and respond promptly as indicated.
4. Member District shall maintain accurate contact information with the SJVPC to assure proper correspondence is maintained.
5. Member District agrees to complete the annual usage documents with accurate information, typically requested in February.
6. Member District agrees to verify contract pricing for purchased items they receive on bid, and monitor contract pricing throughout the school year. Reported discrepancies shall be addressed promptly with distributor and/or vendor.
7. Termination from the SJVPC shall be made in writing to the co-op chairperson.
8. Fees are paid by Member District directly to the Lead Agency, and may include shared cost of advertising of bids, printing, memory devices and postage. Member District agrees to remit promptly upon receipt of invoice.
9. Member agrees to attend or send a designee to each co-op meeting.
