WHEREAS, the Central Union School District has maintained certain positions within the classified category which have been funded under a Grant from the California Department of Education – American Indian Early Childhood Education Grant (AIECE); and

WHEREAS, the AIECE grant funds will end at the conclusion of the 2019-2020 school year; and

WHEREAS, due to these lack of funds to continue services under this program, the Central Union Elementary School Board hereby finds that it is the best interest of this District to eliminate the following services now being provided by the Central Union Elementary School District as outlined below:





Specialty Instructional Aide 5.75 FTE

NOW, THEREFORE, BE IT RESOLVED that as of close of the business day of the 4th day of June, 2020, the two (2) classified positions of the Central Union School District designated above be eliminated as hereinabove set forth.

BE IT FURTHER RESOLVED that the District Superintendent of this School District, or his designee, is hereby is authorized and directed to give notice of elimination of these positions to the affected classified employees of this School District pursuant to District rules and regulations, applicable provisions of the Education Code of the State of California and the collective bargaining agreement with respect to layoff and displacement rights for employees in the impacted classification.
