**A RESOLUTION
REGARDING THE GANN AMENDMENT**

WHEREAS, in November 1979, the California electorate did adopt Proposition 4, commonly called the Gann Amendment, which added Article XII B to the California Constitution; and

WHEREAS, the provisions of that article establish maximum appropriation limitations, commonly called “Gann Limits” for public agencies, including Central Union School District; and

WHEREAS, The Central Union School District must establish a Gann Limit for the 2019-2020 fiscal year and estimate a limit for 2020-2021 in accordance with the provisions of Article XII B and applicable statutory law;

NOW THEREFORE BE IT RESOLVED, that the Central Union School District does provide public notice that attached calculations and documentation of the Gann limits for the 2019-2020 and the 2020-21 fiscal years are made in accord with applicable constitutional and statutory law; and

BE IT FURTHER RESOLVED that the Superintendent provided copies of the resolution along with appropriate attachments to interested citizens of this District.
